Dear Daughters and Adults,

At the Spring Grand Bethel meeting to be held on March 25, 2017, members of the Grand Bethel will have the privilege to elect a Grand Bethel Honored Queen and Grand Bethel Senior Princess for the 2017-2018 Grand Guardian Council year. The Daughters who aspire to the elected offices of Grand Bethel Honored Queen or Grand Bethel Senior Princess, must meet the eligibility requirements as listed below in the Grand Bethel Rules and Regulations.

If you are interested in making application, please read the following very carefully:

Article V Grand Bethel Offices

Section 1. Process for selection of Elected Grand Bethel Officers

A. Daughters who aspire to the elected offices must meet eligibility requirements as defined

1. To be eligible to be an applicant for Grand Bethel Elective Office, the Daughter must be a current spring term Honored Queen and/or any Past Honored Queen who are members in good standing in their Bethel . They shall have been in regular attendance for a six (6) months prior to aspiring for an office in Grand Bethel.

2. The Grand Bethel Honored Queen candidates shall be at least sixteen (16) and not yet twenty (20) years of age at the time of the last business day of the Annual Session. Grand Bethel Honored Queens cannot be installed at age 20 unless she has her CAV card.

3. The Grand Bethel Senior Princess candidates shall be at least fifteen (15) and not yet nineteen (19) years of age at the time of the last business day of the Annual Session.

4. Daughters who aspire to the office of Grand Bethel Honored Queen and Grand Bethel Senior Princess will submit an application to the Youth Committee thirty (30) days prior to the spring Grand Bethel Congress. See Oregon Grand Bethel 6, Art. VI, Sec. 4 (a).

The Application Packet will include:

Form A: Applicant Basic Information Letter.

Form B: "Job's Daughter" resume.

Form C: Bethel Guardian Secretary Verification form.

Form D: Statement of parental support signed by the parent/legal guardian.

Form E: Confidential Daughter recommendations from the applicant's home Bethel

Form E: Confidential Bethel Guardian Council recommendations from the applicant's home Bethel

Form E: Confidential Bethel Grand Deputy recommendation (if applicable)

5. Applications may be rejected by the Youth Committee

a. Applications which are not complete may be rejected by the Youth Committee.

b. Applications which do not have endorsement from the parents, Daughters, Bethel Guardian Council, and/or Bethel Deputy may be rejected by the Youth Committee.

B. The Grand Bethel Electoral College shall elect the Grand Bethel Honored Queen and Grand Bethel Senior Princess as outlined in Oregon Grand Bethel Rules and Regulations Article. VI, Sections 3 and 4.
