## Appendix B Miss Oregon Job's Daughter Regalia Protocols

The Miss Oregon Job's Daughter Program of Oregon has a rich tradition that includes distinguished regalia for its Miss.

## **History:**

Since the inception of the Miss Oregon Job's Daughter Program of Oregon in 1998, the Miss has been provided with beautiful regalia to complement her own wardrobe. The first crown of the Miss Program was donated by Allison Stacey Priest, PHQ #24 and a dark royal blue velvet cape with golden satin lining was created, the colors emblematic of the distinct State Flag of the great state of Oregon. Red roses were declared as the official flower of the program, in honor of Portland, Oregon, the "City of Roses" where an annual Rose Festival is held.

With the adoption of a new robe project, it is prudent that specific protocols be put in place to outline the proper care and use of Grand Bethel regalia, including all royalty regalia.

## **General Provisions:**

- Miss Oregon Job's Daughter regalia is property of the Miss Oregon Job's Daughter Program and under the care of the Miss Oregon Job's Daughter Coordinator (or an appropriate designee) and the Youth Committee.
- 2. Miss Oregon Job's Daughter shall be privileged to wear the official regalia of the MOJD program in the official execution of her duties The following activities are considered to be within the official duties of the Miss at which her attendance would be welcome or required:
  - a. Miss Oregon Job's Daughter Pageant and related activities
  - b. Supreme Session Opening and Flag Ceremony (Supreme Bethel Meeting??)
  - c. Miss International Job's Daughter Pageant held at Supreme Session
  - d. Formal Opening for Grand Session
  - e. Grand Bethel Installation
  - f. Grand Bethel Weekend (for both the meeting or ceremony)
  - g. Statewide Initiations (Official Regalia of Job's Daughters International shall be worn at all Initiations if she is taking an active part in the Initiation)
  - h. Heritage Day
  - i. Grand Bethel Majority Ceremony
  - i. Grand Bethel Degree of Royal Purple
  - k. Visitation to local Bethels
  - I. Any other event approved by the Youth Committee
- 3. All MOJD regalia and paraphernalia taken by a Daughter or adult shall be returned in the same good condition it is provided or they shall be responsible for replacing same in the event of loss or damage. The Daughter and her parents, or the adult who had the regalia or paraphernalia shall pay the actual cost for repair or replacement.

## **Specific Protocols for Miss Oregon Job's Daughter Cape and Crowns**

- 1. The official cape of Miss Oregon Job's Daughter shall be dark royal blue on the exterior of the cape and golden satin lining. The specific hues are intended to represent the distinct color of the State Flag of the great state of Oregon. Red roses were declared as the official flower of the program, in honor of Portland, Oregon, the "City of Roses" where an annual Rose Festival is held. The original MOJD cape had small red ribbon roses added as an adornment.
- No alterations may be made to the MOJD capes without the express written authorization
  of the MOJD Coordinator AND the Youth Committee Chair, after consulting with the Grand
  Guardian and Youth Committee. Crowns may only be replaced or repaired upon approval
  of the Youth Committee.
- 3. MOJD Royalty Regalia
  - a. The Miss shall be privileged to wear official MOJD cape provided by the Youth Committee in the performance of her official duties.
  - b. There are currently two capes for the MOJD Program. The Miss will only travel with one cape and should use extreme care when using and storing this piece of beautiful regalia. The Youth Committee will determine which cape is the traveling cape and which cape shall be retained for official use. Replacement costs for the capes have been estimated to be over \$750.00 each.
  - c. The MOJD Program currently has 3 distinct crowns for use by the Miss.
    - MOJD Crown #1 the original MOJD crown (silver with pearls) (donated by Allison Stacy Priest, PHQ #24)
    - ii. MOJD Crown #2 gold with pearls (donated by Past MOJD's)
    - iii. MOJD Crown #3 the official Doc Morgan crown for Miss Oregon Job's Daughter. This crown was purchased and donated by the parent of MOJD 2014-2015, Miss Brooke White.
    - iv. The MOJD traveling cape and crown are only to be worn in carrying out the official duties of MOJD when outfitted in a long formal. A crown may be worn with tea-length or shorter gowns or dresses, however the cape may only be worn with long formals.
    - v. The Miss shall be privileged to keep the MOJD cape, crowns and sash for use throughout the year at appropriate events
  - d. Each Miss will also be furnished with a sash signifying her office. Upon her selection she may have the sash personalized at her own expense. The sash shall be ordered by the MOJD Coordinator for presentation at the annual MOJD Pageant.
  - e. Sashes may be worn with formals, tea-length and day dresses, as well as with dress pants. Crowns may be worn with dresses, but never worn with pants. Crowns and tiaras may NEVER be worn in a vehicle. NO exceptions to this rule!!!

Sashes, crowns and tiaras may not be worn with jeans or grubby clothing.

f. The MOJD Coordinator shall see that the MOJD cape is cleaned as deemed necessary. An inspection of the MOJD cape will be done annually at Heritage Day and at the Annual MOJD Pageant.
